NOTICE OF AN APPLICATION FOR CONSENT Section 53 of the Planning Act, R.S.O. 1990 (Chipman Road, Vacant Lot, Brockville - File B01/19)

The Chief Planning Officer for the Corporation of the City of Brockville is in receipt of an Application for Consent to consider a proposed severance with respect to the lands referenced below:

Location of property: Chipman Road (Vacant Lot)

Description of lands: Lot 5, Plan 376, City of Brockville, County of Leeds

Proposed Severance: The proposed 3.0 m wide x approximately 54.8 m long easement across Lot 5, Plan 376, Chipman Road would accommodate water and sewer lines servicing 33 Swiftwaters Road.

Retained Lands: Existing boundaries are not changing.

The subject lands are not the subject of any other applications under the Planning Act at this time.

A sketch respecting the above noted file is available for review in the Planning Department during regular office hours (8:00 a.m. – 4:00 p.m.).

The Chief Planning Officer, as the delegated approval authority for the City of Brockville, will consider this application on or after **23 May, 2019**.

To make comment on the Application for Consent, please do so in writing to the attention of the Chief Planning Officer, c/o City of Brockville, Victoria Building, One King Street West, P.O. Box 5000, Brockville, Ontario, K6V 7A5, no later than **22 May, 2019**.

If a person or public body that files an appeal of a decision of the Chief Planning Officer in respect of the proposed consent does not make written submission to the Chief Planning Officer before he gives or refuses to give a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.

To be notified of the decision of the Chief Planning Officer in respect of the proposed consent, a written request must be made to the Chief Planning Officer at the address noted above.
